ORDINANCE RELATING TO Ph.D. DEGREE



ORDINANCE 124

(REVISED AS PER UGC REGULATION 2009)

O-124. A. Eligibility of Research Scholars and Supervisors

- (1) A candidate for admission to the degree of Doctor of Philosophy (Ph.D.) in the Faculties of Arts, Commerce, Education, Fine Arts, Music and Dramatics, Law, Management Studies, Science and Social Science must have obtained the Master's degree (not the Diploma) with at least 55% marks at the postgraduate examination of the University in subject or any allied subject in which he/she wishes to pursue research. If the candidate secures less than 55% marks at the postgraduate examination but secures a second division at postgraduate as well as at degree level, he/she will be eligible for admission to the degree of Ph.D. However, in exceptional cases relaxation in minimum eligibility condition may be given by the Vice-Chancellor in consultation with the subject expert.

Provided that:

- (i) The Master's degree should have been obtained after taking the Bachelor's degree with full prescribed Courses for the degree.
 - (ii) Candidate who obtains the B.A. degree from other statutory Indian University as Oriental candidate after passing a public examination in a classical or modern Indian language prior to his/her M.A. degree will also be eligible for registration.
 - (iii) The eligibility condition for teachers having been recruited before 1986, may be relaxed at the discretion of the Standing Committee. For the purpose of Ph.D. registration a teacher candidate will be defined as a person working in a permanent capacity as a teacher in a recognised University/College.
 - (iv) No candidate shall ordinarily be permitted to register for Ph.D. degree in a subject different from the one in which he/she has passed his/her qualifying examination. However, in order to facilitate inter-disciplinary research a candidate may apply in allied subject and his/ her registration may be considered on approval of the Vice Chancellor and in such cases co-supervisor may be appointed if supervisor so desires with necessary justification (Appendix IV). The co-supervisor also has to be a recognized supervisor of the University.
- (2) The Standing Committee shall be constituted for the purpose of considering all matters, related to the registration Ph.D. scholars, which need clarification. The Standing Committee shall consist of

five members, having at least 15 years research guidance experience, nominated by the Vice-Chancellor in addition to Director Research who shall act as convener. The implementation of recommendations of the standing committee will be subject to the approval of the Vice-Chancellor.

- (3) To coordinate the research activities of the University, a Director Research will be nominated by the Vice Chancellor from amongst the faculty members of the University/affiliated college, having at least 15 years of research supervisory experience.
- (4) The following persons will be eligible to act as research supervisors provided they possess a doctoral degree of a recognised University:
 - (i) Professors and Associate Professors of the Teaching Departments of Maharaja Ganga Singh University, Bikaner.
 - (ii) all other permanent teachers of the University Teaching Departments not covered under 4(i) and permanent college teachers affiliated to this University having 5 years PG teaching/Post-doctoral research experience. In either case the teacher must have published atleast 3 research papers in recognised journals of national/international level and also participated in at least two conferences/seminars of the area of research work concerned.
 - (iii) retired teachers employed on regular basis in private institutions affiliated to the University may be recognised as research supervisors subject to fulfilling other eligibility conditions, until the age of 65 years or one year prior to their retirement, whichever is earlier, on approval of the Vice-Chancellor.
 - (iv) an outstanding and eminent scholar who may be working outside the jurisdiction of colleges affiliated to the Maharaja Ganga Singh University, Bikaner may be considered for recognition as research supervisor on approval of the Vice-Chancellor. To decide eminence of scholar, a committee will be constituted by the Vice Chancellor consisting of Dean of Faculty, Convener of Board of Studies concerned and two subject experts of other universities.
 - (v) a research supervisor, who has no previous experience of research supervision, will not be allowed to register with him/her more than two research students in the first year from the date of enrolling first scholar under his/her supervision.
 - (vi) the maximum limit of number of research scholars at a time with a research supervisor shall be as shown in Appendix-I.

- (5) (i) No person shall be permitted to supervise the research work of his/her close relations (The term 'close relations' as defined in the examination ordinance of the University.)
- (ii) A candidate for degree of Ph.D. shall be allowed to work only in those institutes/colleges affiliated to this University which have PG classes in the subject concerned.
- (iii) A teacher shall not be entitled to supervise research work, irrespective of his eligibility as a guide, if the institute/college in which he is posted does not have PG classes in the subject concerned.
- (iv) Permission for Ph.D. work to be carried out in a new PG college shall be granted only, if recommended by an inspection committee constituted by the Vice-Chancellor. The Inspection Committee will consist of:
1. Dean (Concerned faculty)
(Convener)
 2. One Subject expert
 3. One University Professor in the subject concerned, if available, otherwise, one more subject expert.
- (6) In case the supervisor retires or leaves the University/College, the candidate shall be permitted to continue his/her work under his supervision by paying necessary fees to the college from which he/she had applied for registration.
- (7) In the event of death of the supervisor or in exceptional circumstances a change of supervisor shall be permitted and the period of his/her research work shall be counted for the purpose of the award of the Ph.D. degree.

O-124. B. Entrance Test and Admission

- (1) Admission to Ph.D. will be made through a Combined Entrance Test for M.Phil./Ph.D. to be conducted by the university every year. The candidate may fill up option for M.Phil. or Ph.D. or both in the application form.
- (2) The test will be followed by an interview to be conducted by the two Subject Experts to be appointed by the Vice Chancellor in consultation with the Director Research, to adjudge the research interest of the candidate. The Test will be of maximum 300 marks and interview of 30 marks. The number of candidates called for interview will be five times the number of available seats in a subject. Merit will be drawn from the combined marks obtained by the candidates in the Entrance Test and Interview (Max. Marks 330). Admission will be given against available vacant seats in a subject. Reservation policy of the State Government shall be followed while giving admission.

- (3) The students who have qualified UGC/CSIR (JRF) Exam./SLET/SET/GATE/Teachers Fellowship holder have also to appear for combined entrance test for M.Phil./Ph.D. to get admission to M.Phil/Ph.D.
- (4) The students who have passed M.Phil. degree shall also have to appear for combined entrance test for Ph.D. to get admission to Ph.D.
- (5) The number of available vacant seats in each subject will be determined and announced in the notification for entrance test. A statement filled up by each registered supervisor of the university will be obtained every year to verify the number of allotted and vacant seats under him/her and willingness to accept new candidates. A seat will be deemed to have fallen vacant under a supervisor on submission of the thesis by a research scholar under him.
- (6) The provisional admission for the Ph.D. degree will be given as sub-clause (2), (3) and (4) of the clause B, subject to availability of seats in concerned subject.
- (7) A candidate admitted for Ph.D. degree shall pay a Registration fee and Coursework examination fee to the university as provided under Appendix- XII, or as amended from time to time by the university. The candidate will submit his/her joining of research programme to the university through proper channel.

O-124. C. Course work

- (1) A candidate admitted for Ph.D. degree shall have to undertake a course work of 6 months duration. The syllabus of this course work will be framed by the respective Boards of Studies in the light of Para 13 of UGC Regulation 2009.
- (2) On completion of course work, the university will conduct an examination of descriptive nature of 100 marks. A candidate securing minimum pass marks (45%) will only be considered eligible for final registration.

O-124. D. Research work

- (1) The Research Committee of the university will allot the supervisor to the qualified candidates by calling them for personal interview. The Research Committee will consist of the following:
 - Vice Chancellor (or his Nominee, not below the rank of Professor) - Chairman
 - Dean of the concerned Faculty
 - Convener-BOS in concerned Subject
 - Subject Expert (to be nominated by Vice Chancellor)
- (2) The candidate will submit a research proposal to the university through his/her supervisor in the prescribed format which will be evaluated by an expert to be nominated by the Vice Chancellor.

- (3) On receiving positive report from subject expert so appointed under subclause (2) above, the final registration will be made and the candidate will pursue his/her research work at the headquarters of the supervisor and seek admission at that institute/college by paying necessary fees. The upper limit of the fee to be charged by any institute/affiliated college will be decided by the university from time to time. A joining report will have to be furnished to the Principal of the College/ Head of the University Department with a copy endorsed to the University within 30 days from the issue of letter of approval of synopsis by the university; failing which the candidature of the Ph.D. candidate will automatically be treated as cancelled. The university will issue the final registration letter confirming the date of commencement of work. The date of commencement of work will be either the date of submission of synopsis or the date of joining which ever is later, as will be communicated by the candidate through supervisor along with the joining report.
- (4) The candidate shall pursue his/her research work at the headquarters of the supervisor. The supervisor shall certify that the candidate has put in at least 200 days of attendance every year. This condition of attendance, however, would not apply to a teacher candidate except in cases where he/she is a teacher fellow/ a full-time paid researcher. For this purpose, a Teacher Candidate is defined as any permanent teacher working in College/University who has produced a no-objection certificate from the employer. The 200 days attendance per year will also include any period spent away from headquarter for field work and library consultation, as may be certified by the supervisor.
- (5) No candidate registered for Ph.D. degree shall be allowed to seek admission to any other courses of this University or elsewhere.
- (6) The date of registration will be the date of commencement of work as specified in sub-clause 3 above. The minimum time period for submission of the thesis shall not be earlier than two years and not later than five years from the date of final registration. After completion of five years ordinarily the period shall not be extended except in exceptional circumstances where an extension of maximum of one year may be permitted by the Vice Chancellor on the recommendation of the supervisor routed through the Head of University Department/Principal of the concerned college. On expiry of the extended period, the registration of the candidate shall automatically stand cancelled.
- (7) The topic of research shall ordinarily not be modified after registration. The supervisor may, however, recommend a change in the topic if it is subsequently found that a modification is necessary in the interest of research. This matter shall be reported to the Standing Committee which shall forward its recommendation to the Vice-Chancellor for approval. Such change, however, would be done only once. The candidate shall be permitted to submit the thesis only one year after the approval of the change of the topic by the Vice-Chancellor subject to minimum submission period.

- (8) Six months before the submission of thesis, the supervisor shall submit four copies of the summary of work along with a panel of at least eight experts in the subject concerned, having not more than two examiners from Rajasthan and not more than two from outside the Country (Appendix-V). The Vice-Chancellor may, however, ask for more names of experts from the supervisor and in exceptional cases, may add names to the panel. The Vice-Chancellor would then select and appoint two examiners from the panel. At least one examiner should be from outside the state of Rajasthan. The candidate shall be required submit the thesis within six months of the submission of panel of examiners, however, only in extra ordinary cases the Vice Chancellor may extend the time.

O-124. E. Evaluation of Thesis and Award of degree

- (1) On completion of research work the scholar shall produce a draft thesis and make a presentation in the Department of the Supervisor that may be open to all faculty members and research students, for getting feedback and comments, which may be suitably incorporated into the draft thesis under the advice of the supervisor. A certificate signed by the Supervisor and Head of the Department/Principal of the College shall have to be submitted along with the final thesis stating that the scholar had made an open presentation and had also incorporated the relevant suggestions made during presentation.
- (2) Ph.D. scholar shall publish one research paper in a referred Journal before the submission of the thesis and produce evidence for the same in the form of acceptance letter or the reprint to be attached to the thesis.
- (3) The scholar shall also submit a soft copy in the form of CD/DVD of the thesis.
- (4) After the thesis is complete, the candidate shall submit four printed or typewritten copies in a bound-cover of the colour specified in Appendix-VI along with certificate by the supervisor in the proforma provided in appendix-VIII and no-dues certificate by the concerned Head of the University Department/Principal of the PG affiliated college.
- (5) The language of the thesis shall be either Hindi or English except that for theses submitted in the area of languages such as Sanskrit, Urdu, etc.
- (6) The candidate shall not incorporate the results of his/her research work done at the Master's of M.Phil. level.
- (7) The thesis must be a piece of research work characterised by the discovery of facts or by fresh approach towards the interpretation of facts or theories on an applied work of great significance. In either case it shall evince the capacity of the candidate for critical examination and independent judgement. It should be satisfactory so far as literary presentation is concerned and must be suitable for publication.
- (8) The evaluation of the thesis shall take place in the following manner.

- (i) It will be examined by the supervisor(s) and external examiners appointed in the manner specified above. All the examiners shall be requested to submit a report, normally within a period of two months of the receipt of the thesis in the format provided in Appendix-IX and shall be paid remuneration at rates specified in Appendix-XI.
- (ii) If all the examiners unanimously recommend acceptance of the thesis and award of the degree of Ph.D., the Vice-Chancellor shall appoint one of the two external examiners to conduct the viva-voce examination. The viva-voce shall be conducted jointly by the supervisor(s) and external examiner so appointed. It would be notified that teachers and research scholars may attend the viva-voce examination at their own expenses. However, questions, clarifications, etc. shall only be asked by the examiners. The examiners shall submit their viva-voce report jointly to the University in the format provided in Appendix-X. The report shall then be placed before the Vice-Chancellor for approval, and if the recommendation is found positive, provisional degree certificate may be issued to the candidate and the degree shall be conferred after approval of the Academic Council.
- (iii) In case one or more external examiners recommend a modification in the thesis, it will be communicated to the candidate by the University and the candidate will be required to modify thesis as suggested by examiners and resubmit the thesis not before a period of six months. The process of evaluation outlined above will then be followed.
- (iv) In case one of the external examiners recommends the rejection of the thesis, the thesis shall be sent to a third external examiner and the opinion of the third external examiner shall be final.
- (v) In case one external examiner recommends a modification while another rejects the thesis, the candidate shall be informed accordingly and asked to resubmit the thesis after a period of one year. The revised and/or modified thesis shall be sent to the same two examiners. If, even then, any one of the external examiners, recommends further modification/rejection, the thesis will be rejected and the registration shall automatically stand cancelled.
- (vi) If both the external examiners recommend the rejection of the thesis, it will be rejected and the registration shall automatically stand cancelled.
- (vii) The period of six months/one year spent in resubmission of the thesis after modification shall be counted from the date on which the candidate is informed about the same and this

period shall not be counted to compute the maximum period for submission of thesis i.e. five years from the date of registration.

- (viii) If viva-voce report is unsatisfactory the viva-voce examination shall be normally reheld after period of three months from the date of first viva-voce examination on payment of the requisite fee. If the candidate fails to get a satisfactory report in the second viva-voce examination the thesis shall be rejected and his/her registration shall automatically stand cancelled.
- (ix) Following the successful completion of the evaluation process, the University shall submit the soft copy of the thesis to the UGC within 30 days for hosting the same in INFLIBNET.
- (x) The degree of Ph.D. thus awarded shall be accompanied by a certificate to the effect that the degree has been awarded in accordance with the provisions of the Regulation of the UGC 2009.
