IInd Symposium on History of Bikaner February 27, 2017 Bikaner through the Ages

INVITATION

The Department of History, Maharaja Ganga Singh University Bikaner is organizing a symposium on "Bikaner Through the Ages". The aim and objective of this symposium is to discover and bring to light the new facts and forgotten pages of the history of Bikaner division located in the midst of Thar desert of north – western Rajasthan, also referred to as *Jangaldesha* and *Madreya Jangalah*. This highly important region once witnessed the rise and growth of a very rich human civilization flourishing in the catchment areas of glorious rivers Saraswati (identified with modern Ghaggar river) and Drishadvati. There existed a large river system in which these rivers along with hundreds of their tributaries flowed and contributed towards the growth of a highly rich human civilization referred to as Saraswati-Indus Civilization. This region also witnessed the migration of several peasants, artisans, trading communities as well as human races such as Greeks, Scythians, Parthian etc. who traversed this region and also added to the colours and glory of Maru Pradesh. In the Early Medieval period, Bikaner witnessed the emergence of Jats, Johiyas, Bhatis, Sankhlas, Mohils and other artisanal as well as the peasant communities which were possibly autonomous in nature.

In the first half of 15th century, the migration of a strong contingent of Rathores under the leadership of Rao Bika is an event of far reaching importance in the region which resulted in formation of a strong centralized state in collaboration with indigenous clans which were till then autonomous. The successive Rathore rulers effected alliances with the central authorities of Delhi and worked for consolidation of the state as well as for material progress of the region. The induction of the rulers of Bikaner as Mughal mansabdars exposed this region to the central authority. The Rathore rulers by virtue of being the pillars of Mughal Empire brought peace, prosperity and stability to this region. Similarly, during the British period, the level of socioeconomic development of this region reached new heights when the projects of Bikaner Railway, Gang Canal, roads, hospitals etc. were executed. Thus, the erstwhile Bikaner State emerged as a jewel in the crown of mother India with its distinct and unique identity across the globe. Equally important is Bikaner's Rishi Parampara, glorious cultural tradition, dress and costumes, art and architecture, social values, ethos, folk songs, folk art and literature in the golden pages of the history of Bikaner.

Keeping in view the significance of the history of this region and its geopolitical and strategic importance, the Department of History is organizing a daylong symposium on some unexplored aspects of the history of Bikaner with the aim of discovering and highlighting new facts and sources for reconstruction of the history of this region. The broader themes of this symposium are as follows:-

- 1. Sources of the History of Bikaner
- 2. Bikaner in the age of Vedas, Epics and Puranas
- 3. Saraswati-Indus Civilization and present Bikaner region
- 4. Rishi Parampara of the ancient Bikaner
- 5. Advent of Shakas, Hunas, Greeks etc. in Bikaner and their impact on society and culture
- 6. Society, culture and polity of Bikaner in Pre-Rathore period
- 7. Castes, communities peasants, nomadic tribes, artisanal castes of Bikaner State: their origin and history
- 8. Migration of Rathores and the process of state formation and its consolidation
- 9. Battle of RatiGhati and subsequent Rathore-Mughal Alliance and Relations
- 10. British-Bikaner relations

Methodology: In a daylong symposium, resource persons shall deliberate upon contentions and burning issues concerning the history of Bikaner. The participants of the symposium would also present papers and shall share their views to bring into light the unexplored areas of the history of this region. It shall be our endeavour to prepare an action plan which shall help in systematic reconstruction of the history of north-western region of Rajasthan.
